

Camino Delights Citizens by Simplifying Extensive Permit Process





Overview

Fairfax County, with over 1.1 million residents, is the Commonwealth of Virginia's most populous jurisdiction meaning there's significant demand for its Land Development Services (LDS) department. LDS, which manages land development, code enforcement and regulations for the county, has struggled to communicate and capture the extensive development processes across its multiple departments.

Camino's Permit Guide unified the cross-departmental information while streamlining communication with residents. Camino achieved this alongside the county's existing Accela system.

Challenged to capture extensive processes

Fairfax County is committed to service excellence. Each year the County's Land Development Services reviews over 30,000 building and site plan submissions, issues nearly 70,000 building permits and conducts over 220,000 building and site inspections. Before using Camino, it was challenging to capture the extensive processes, codes and regulations that projects must adhere to. PDFs were produced for in-person guidance and made available online. Inevitably the versions handed out and online would not be the same. Web pages were long, not easily printed and proved confusing for new customers to read. The department found itself overwhelmed with questions and calls.

Fairfax County's Director of Land Development Services asked his team to look into Camino. The County started with a pilot launch that was very well received by residents. Today, Fairfax County uses Camino Guides to unify data across all the agency's departments. The County is also using Camino to communicate how its new permitting system works to staff and residents. 
